### COMPATIBILITY

Standard bottle cages, and non-carbonated liquids ranging from cool to cold. **NO HOT LIQUIDS.** Bottle can be frozen.

### CARE AND MAINTENANCE

**Dishwasher safe, although it is not recommended.**

- Any plastic container can warp if exposed to extreme heat. Any warping of the bottle can lead to leaks over time
- In order to get the longest life out of the bottle, rinse it with warm water and detergent after every ride. Hand wash and don't use abrasive brushes, scouring pads

### ADDITIONAL INFO ON PURIST WATER BOTTLES

**Avoid "scrubbing" the inside of the bottle.**

- Purist water bottle technology has a micro layer of a glass-like material that can be scratched if you use something abrasive. Scratches can create areas for things to stick to the bottle, and should be avoided on any water bottle

**The MoFlo and Watergate caps can be disassembled and cleaned when needed.**

- Twist counter clockwise and pull. Some small pieces. Not recommended for children
- Cap may need re-lubing after a few washes- this can be done with a dab of vegetable oil or petroleum jelly on the o-rings in the caps

### LIMITED WARRANTY

Foundry Cycles warrants parts and accessories against manufacturing defects in materials, craftsmanship and design for a period of one year from the date of purchase for only the original owner with accompanying proof of purchase.

This warranty applies to and covers only Foundry Cycles parts and accessories.
